LunaBot Terms of Service

Welcome to LunaBot! These Terms of Service (“Terms”) govern your access to and use of the LunaBot software, services, and related content (collectively, the “Service”). By installing, inviting, or using LunaBot, you agree to be bound by these Terms. If you do not agree, do not use LunaBot.

1. Acceptance of Terms

By accessing or using LunaBot, you represent that you are of legal age to form a binding contract and agree to comply with all applicable laws and these Terms. You affirm that you have the authority to act on behalf of your Discord server(s).

2. License and Use

2.1 Grant of License: LunaBot grants you a limited, non-exclusive, non-transferable, revocable license to use the Service strictly in accordance with these Terms.

2.2 Restrictions: You may not:

- **Reverse engineer, decompile, or attempt to extract source code.**
- **Modify, distribute, sell, sublicense, or lease any part of LunaBot.**

- **Use the Service to violate any applicable law or Discord's Terms of Service.**
 - **Use LunaBot in a manner that harms, abuses, or disrupts other users or Discord's platform.**

4.2 Data is stored securely and used solely to operate and improve LunaBot. We do not sell or share personal data with third parties except as required by law or for trusted service providers under confidentiality agreements.

4.3 By using LunaBot, you consent to such data processing in accordance with our Privacy Policy.

4.4 You agree to inform your Discord server members of LunaBot's presence and data practices.

5. Bot Availability and Updates

5.1 LunaBot is provided on an “as is” and “as available” basis. We do not guarantee uninterrupted operation or specific response times.

5.2 We reserve the right to update, modify, suspend, or discontinue LunaBot at any time without liability.

5.3 Scheduled or emergency maintenance may cause temporary outages; LunaBot’s team will strive to minimize disruptions.

6. Intellectual Property Rights

6.1 LunaBot and all related intellectual property rights remain the exclusive property of LunaBot’s developers and licensors.

6.2 You may not copy, adapt, or create derivative works without explicit permission.

6.3 Discord trademarks and assets used within LunaBot belong to Discord and are used under their brand guidelines.

7. Indemnification

You agree to defend, indemnify, and hold harmless LunaBot’s developers, affiliates, and partners from any claims, damages, liabilities, costs, or expenses arising from:

- Your misuse or unauthorized use of the Service.
 - Violation of these Terms.
 - Violation of any third-party rights or laws.
